# LTC: Coming to Washington

Washington is the first State in the Nation to create a long-term care Trust program funded 100% through an employee-paid payroll tax. As of 1/1/2022, all W-2 employees working in the state will need to either have long-term care coverage from the State or purchased through an insurance company.

Coverage through the State: A 0.58% tax will be required on all W-2 earnings (base, bonus, commission, etc.), benefits will be \$36,500 per lifetime, and benefits will be payable only when residing in the state when receiving benefits. Benefits are not available immediately: workers will need to pay into the program for at least 3 years for temporary vesting and 10 years for permanent vesting.

Coverage through an insurance company: For those who purchase coverage prior to 11/1/2021, they can apply to the state to opt out of the State's program. Premiums are based on the age of the insured, tobacco use, and the amount of coverage elected. Benefits are available once the contract is signed and first premium is paid (after any pre-existing condition waiting period).
