## PBM Drug Pricing Transparency Reform Bill

The bipartisan Senate Committee on Commerce, Science and Transportation approved a pharmacy benefit manager reform bill by a vote of eighteen to nine. This bill not only requires transparency in drug pricing, it also plans to save taxpayers \$740 million over the next decade. The alarming rate of increase in drug prices have hurt consumers' budgets and affected health care costs tremendously.

#### What are some conditions of the Pharmacy Benefit Manager Transparency Act?

- PBMs must pass 100% of any rebate to the plan or payer. Costs and reimbursements of drugs must be disclosed to the health plan.
- It would be illegal for PBMs to charge health plans and payers more for prescription drugs than what they reimburse to pharmacies, otherwise known as "spread pricing."
- Increasing fees or reducing reimbursements in federally funded health care plans in order to offset reimbursement changes would be banned.

Pharmacy Benefit Managers currently operate without much regulation which has allowed out of control drug prices, hurting many families who can no longer afford their medications. Three PBMs control 80% of the prescription drug market, creating a business practice that is hurting the independent pharmacies and putting many small pharmacies out of business. In many rural areas, a pharmacy may be the closest provider for miles around.

Hopefully, this bill will help reduce prescription drug prices, make drug pricing transparent, and provide fair and competitive business practices for all pharmacies. Next, it will go to the full Senate for a vote.


#### Volunteer on our Board!
